**VERY IMPORTANT - Please note the following:**

**MEMBERSHIP FREEZES:** DAM members may freeze their dues one time per calendar year for a minimum of three months and a maximum of six months for no charge. Member must specify the freeze start month and month to resume membership. Requests must be submitted before the first of the month that freeze is to begin. Freezes cannot be retroactive. Membership billing will automatically restart after the freeze period unless the member submits an online cancellation request prior to the end of the freeze period. Members who submit an online request for a freeze or cancellation will receive an email confirmation from DAM upon approval. Members may call the DAM office at 214-219-2300 or email Laurie at ldunlap@damsim.com if they wish to resume their membership prior to the end of the freeze period. For Medical freezes please call the DAM office.

**CANCELLATION POLICY:** All payments are non-refundable regardless of facility usage. **You must give a 30-day written resignation notice. DAM has a 3 month minimum commitment upon joining.**

**FACILITY USE POLICIES:**

Members of the Dallas Aquatic Masters Swim Club may practice at any location during any scheduled practice time. Each location has different guidelines; please make yourself familiar with the policies of the facility you plan on attending regularly. If you are a new DAM member, a temporary membership card will be issued until your DAM Card arrives in the mail. **Baylor (BFC), St. Mark's School, JJ Pearce High School, JCC, Highland Park and SMU and Southlake (CISD Aquatics Center):** Use of these facilities is only during scheduled practice days and times. Facility use at Baylor and Southlake (CISD Aquatics Center) is restricted to 30 minutes prior to start of a scheduled practice or club sponsored event. After a practice has concluded you are asked to leave the facility in a timely manner. If you enter the BFC, you must present your DAM Card. Information on where to park is available on our web page. CISD/City of Southlake residents may also swim at any published adult lap swim time.

As a condition of participation, I, the undersigned, on my own behalf and on behalf of my heirs, legatees, beneficiaries, executors, administrators, legal representatives, successors and assigns, hereby agree that I am voluntarily participating and hereby assume all risk of injury, illness, disability or death, howsoever caused or arising, and do hereby indemnify, remise, release, discharge and forever hold harmless Dallas Aquatic Masters LLC ("DAM") and any pool facility administering organizations and their respective affiliates, parents, subsidiaries, directors, officers, partners, members, managers, shareholders, employees, agents, attorneys, representatives, successors and assigns (collectively, the "Released Parties") from and against any and all actions, causes of action, suits, claims, demands, liabilities, losses, costs (including court costs), damages, awards, penalties, fines, interest and expenses (including attorneys' fees), of any kind or character, asserted against, resulting to, imposed upon or incurred by the Released Parties, directly or indirectly, in any way related to, by reason of, based upon or resulting from any injury, illness, disability or death, howsoever caused or arising, sustained in connection with, arising out of, directly or indirectly resulting from or in any way connected with any DAM practice, competition, event or activity. **THE PROVISIONS OF THIS RELEASE FROM LIABILITY WAIVER SHALL APPLY EVEN IF ANY INJURY, ILLNESS, DISABILITY OR DEATH IS CAUSED, IN WHOLE OR IN PART, BY THE SOLE, JOINT OR CONCURRENT NEGLIGENCE, STRICT LIABILITY, CONTRACTUAL LIABILITY TO THIRD PARTIES, OR OTHER FAULT, WHETHER PASSIVE OR ACTIVE, OF ANY PERSON OR ENTITY, INCLUDING, BUT NOT LIMITED TO, THE RELEASED PARTIES.** The provisions of this Release From Liability Waiver shall inure to the benefit of the Released Parties, their respective heirs, legatees, beneficiaries, executors, administrators, legal representatives, successors and assigns.
